Class SM members shall have all the privileges of the Association.

* **Class C – Assistant Golf Course Superintendent.** To qualify for Class C membership, an applicant shall be, at the time of application for membership, an assistant to a Golf Course Superintendent, and shall be presently employed in such capacity. Class C members shall have all the privileges of the Association with the exception of being an Officer on the Board of Directors.
